

## Trusham Parish Meeting Minutes Monday 13<sup>th</sup> December 2021

### 1. Apologies

### 2. Matters arising from minutes

- 1 C/Fwd - LO is going to organise competition for Road Safety poster
- 2 Rights of way - Teign River Path, letter received from Lower Teign Fishing Assoc explaining they had been unhappy with people and dogs using the stream, for example flea treatments could potentially contaminate the water. IS had looked at objections and thought a blanket ban on usage not a good idea, better to encourage people to understand how we can look after the riverbanks; the River and Canal Trust might be able to provide signage and information. AC to follow up with Hanson & LTFA.
- 3 Litter picking, Teignbridge has grants available for equipment IS and AC will apply for grant.
- 4 Christmas market, donation of £22.50 to THAT from the profit made on the village stall.
- 5 Dog poo, IS chasing dog warden for more advice and signage. AC to investigate further designated bin for disposal of the bags.
- 6 Snow Warden Sam Bull has kindly volunteered to take on this role.
- 7 Committee Membership – offers to join the committee received, AC to follow up with view to joining next meeting
- 8 Community Infrastructure Levy Payment. £2970 is being held by TDC relating to development at Whetcombe in 2013. AC advised there is a statutory time limit to spend and the use is restrictive (relating to community and infrastructure), decision by April 2022 what to spend it on. Ideas included playpark storage, signage “Welcome to Trusham”, another grass cutter, gazebos. AC to pass these ideas past TDC.
- 9 Road Conditions AC reported that Neighbourhood Highways Officer recently visited Trusham since the gully’s have been cleared. Advised that we should be cautious with “homemade” signage if this implies a statutory speed limit is in place.

### 3. Planning

From the plans provided it is difficult to establish exactly where the property is. Neighbours as yet have not received consultation notices from TDC.
