1. Welcome & Apologies

2. Minutes of last meeting & matters carried forward

The minutes of the last meeting were approved.

- a. **Twenty's Plenty Road Safety signage** – most recent identified contractor had not been able to complete work. SB identified a possible option – AC to follow up **Action: AC**
- b. **Repainting of bus shelter** – carried forward, pending completion of mosaic mural
- c. **Website development** – agreed not to progress
- d. **Road repairs** – Contact received from DCC re training for residents on minor road repairs & Lengthsman duties. Chair to write out to village for volunteers **Action: ND**
- e. **Playpark** –New goal post wheels purchased & fitted. Further repairs have been identified including possible additional wood chip. Investigation of this & alternatives. **Action: AC**
- f. **Mosaic in bus shelter** – agreed central funds would cover costs of weatherproof backing tiles needed but mosaics & facilitator costs to be paid by those taking part. Moved to 2025 (February half-term?) **Action: JM / MC**
- g. **Bio-diversity Action Plan** – held over from summer. Will Slatcher has offered additional help with move to Trusham Net Zero, ND to move forward in discussion with Wildlife Wardens. **Action: ND**
- h. **Table tennis table** - has not been used. Ali to ask if anyone prepared to organise a table tennis event. **Action: AC**
- i. **Committee membership** - potential new member identified & agreed Chair to invite to be co-opted. **Action ND**

- a. **Horse Chestnut in playpark** – Chair has received comments that it is becoming too large for the space. Members to visit & feedback. **Action ALL**
- b. **Dog poo** – general communications about problems in Church Lane & incorrect disposal of waste bags. Chair to request additional public bin from TDC & remind all those residential bins not to be used by those passing with waste bags. **Action ND**

- c. Trusham Quarry – DCC consultation for temporary use of hardstanding for parking disability vehicles and minibus conversions – APPROVED (MAY)
- d. Tucketts Barn – sauna & hot tub within rear courtyard - APPROVED
- e. Tucketts Barn – internal alterations & replacement of roof light - ALLOWED
- f. Higher Broomfield – reduce height of tree adjacent Church Lane - ALLOWED
